(Minor injury may occur during free play)

Pets with fleas and/or ticks **will be treated at owners expense**. We make every effort to have a flea and tick free environment, however we cannot be held responsible for such occurrences.

Doggie Do's by Suzanne does not guarantee immunity against communicable diseases beyond its control. Should sickness develop, we reserve the right to incur the cost of a Veterinarian service, the cost of which the undersigned agrees to reimburse.

If owner does not wish to use a local veterinarian, we must have the name and the number of a responsible contact to release said pet to for treatment. In the event the pet is released to someone other then the owner, and kept till owners return, Doggie Do's by Suzanne is not liable for pet after leaving 1550 Flynt Street Griffin, GA
